#### Background and research interests:

Before coming to Keele in 1995 I taught at the University of York for over twenty years, where I was also Director of the Morrell Studies in Toleration. I am Professor of Political Philosophy and former Head of SPIRE.

I am the author of *Political Obligation*, a substantially revised edition of which was published in 2010, and have edited and co-edited several volumes on the political theory of toleration, and also on literature and politics, Alasdair MacIntyre and, most recently, John Gray. In recent years he has also published articles on the work of John Rawls, Brian Barry Michael Oakeshott, Peter Winch, Stuart Hampshire and Charles Taylor, and on multiculturalism, public reason and on the political; theory of modus vivendi. His two-part article on the associative theory of political obligation was published in *Political Studies* in 2006 and 2007



My principal research area is contemporary political theory, and I am currently working on the political theory of modus vivendi.
